Brexit - What to Expect?

With March 29th coming round fast the lack of clarity when it comes to Brexit and the impact this will have throughout the UK is unknown. When it comes to importing and exporting we know that change is coming but to what extent is uncertain so we at Isca Forwarding have begun the process of preparing for all eventualities including the possibility of a no deal Brexit.

New Customs Declaration Service (CDS).

Will replace the current CHIEF system for customs entries and processes. The new system has been modernised and is able to process significantly more entries to allow for increases with the possibility of a no deal Brexit.

Changes to VAT after Brexit.

The UK government intend to continue with a VAT system that will remain as close to the current system as possible.

They will introduce postponed accounting for import VAT so no immediate payment is needed when goods enter the UK.

Changes to Custom Duties & Tariff Rates.

Currently there are no custom duties when entering EU states. Depending on the Brexit deal or no deal this is likely to change and UK businesses may be subject to custom duties. It is likely we will also have to complete import and export declarations as well as some other additional paper work.

Logistical problems the UK may encounter.

With the increase of documentation required for customs declarations vehicles entering the UK via a roll on roll off service may face delays as customs checks are performed. The Government are looking into holding areas to reduce delays but a solution has yet to be determined.

Members of the Common Transit Convention.

As of the 18th of December 2018 it has been confirmed by the UK Government that the UK has successfully negotiated membership into the CTC. This is the case regardless of any deal agreed or in the case of a no deal Brexit. This means the UK has free trade movement between EFTA countries (Iceland, Norway, Lichtenstein and Switzerland) as well as Turkey, Macedonia and Serbia. This will provide both cash flow benefits and aid trade flow as customs declarations will only be made and import duties paid on arrival at final destination.



How Can You Prepare For Brexit?

Although there is still a great deal of uncertainty regarding Brexit and how it will impact UK businesses and their importing and exporting with Europe. There are a few things businesses can do in preparation to help with the changes.

An FORI Number

If you do not already have an EORI number from importing or exporting internationally, now is the time to apply. It is a simple process which can be completed online and will be a requirement post Brexit. You can apply for an EORI number at the web address below:-

Commodity Code

It is a good idea to familiarise yourself with the commodity or tariff code of your products. These codes will be required for customs entries and you can find out your product's code at the below web address:-

Licenses and Restrictions

When you have determined your commodity code you can also establish if your goods require any licenses or have any restrictions in place when importing or exporting them. It is important to know this information for customs entries to ensure a smooth customs clearance process.

Customs Entries

To complete customs entries you will require the correct computer software or work with a freight forwarder who will complete the entries on your behalf. Make sure you choose a freight forwarder who will work with meeting your company's needs and is happy to explain and talk you through the changes and requirements as Brexit is put into practice.
